We truly are making progress through your support.

This past year marks another year of achievement and transformation in the life of the College:

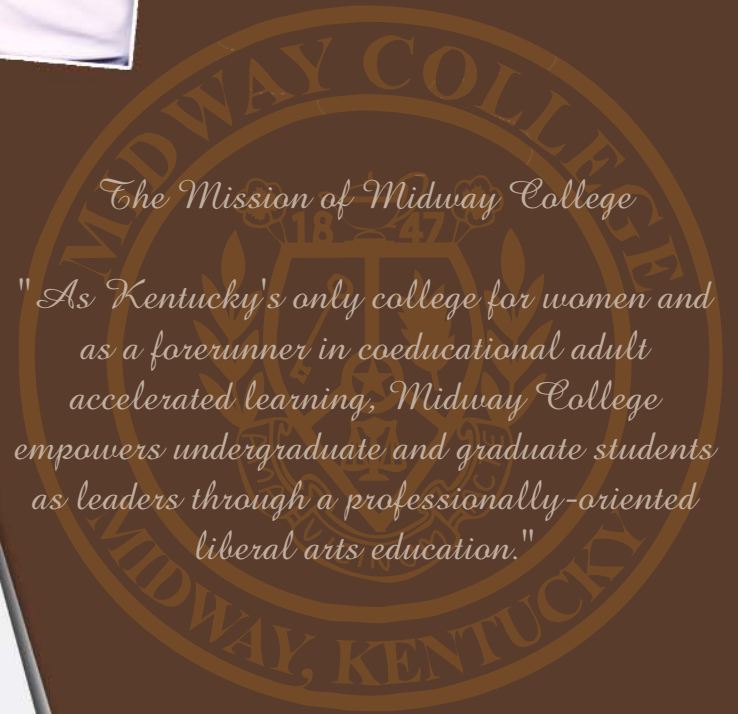
- Midway College was granted Level III status by the Southern Association of Colleges and Schools to offer graduate degrees;
- the Class of 2008 consisted of 334 graduates, a College record;
- Ashland Inc. made a \$1 million lead gift as part of a \$5 million capital campaign to renovate Starks Hall;
- the Endowing Midway's Purpose campaign has received \$4,001,240 in pledge commitments;
- for the fourth consecutive year 100 percent of the faculty and staff participated in the annual fund campaign;
- the number of alumni gifts increased by 25 percent;
- the Midway College Lexington Campus at Hamburg opened.

Our continued success in adult education has propelled us into the next major transformation of Midway College: graduate education. The first class in the Master's of Business Administration (MBA) began this spring. This program will enhance Midway's overall business education and the accreditation application process will set a foundation for offering additional graduate degrees in the near future.

Additionally, Midway's focus remains on the Women's College as part of our dual mission. Approximately 470 students study within 17 different majors, all of which are oriented toward one of four professional programs in teacher education, nursing, equine studies or business. Student athletes compete on 10 sports teams and equine students operate a 160-acre farm adjacent to the campus. The Women's College educational experience is expensive and accomplishing the Endowing Midway's Purpose campaign goal of \$13.75 million is critical. We are pleased by the success of this campaign and encourage you to consider how you might support this effort.
